



Open Access Publication Policy

SLACK Incorporated offers two options for publication under the gold open access model:

- Publication in a full open access journal that makes all articles freely available online immediately upon publication in exchange for payment of an article processing charge upon article acceptance.
- Publication in a hybrid open access journal, which is a primarily subscription-based journal that provides open access only for those individual articles for which the article processing charge is paid upon article acceptance. Note that the hybrid open access option is not available for certain journal columns and/or departments. Please contact the specific journal for more details.

PEER REVIEW AND MANUSCRIPT QUALITY

All open access articles are treated in the same way as any other article submitted to SLACK Incorporated. Submitted manuscripts undergo the journal's standard peer review process, including review by both the Editorial Board and Editor in Chief, and are accepted or rejected based on their own merit. Open access publication is offered only to those authors whose articles have been accepted for publication, and only at the point when the article is accepted, to ensure the open access option has no influence on the peer review process.

Accepted articles are professionally copyedited and sent to the author(s) for approval before posting online at Healio.com. Articles are archived for perpetuity and submitted to relevant abstracting and indexing services.

COPYRIGHT AND SCHOLARLY COMMUNICATION RIGHTS

Under SLACK Incorporated's Open Access Publication Policy, the authors retain the copyright to their article. No rights in patents, trademarks, or other intellectual property rights are transferred to the journal.

SLACK Incorporated will publish and distribute the article with the appropriate copyright notice and Creative Commons license where applicable.

Upon acceptance, open access article authors are asked to agree to our License Agreement for Open Access. This broad license has been developed to facilitate open access to original works of all types for personal, research, and educational use but not necessarily commercial use.

CREATIVE COMMONS LICENSES

SLACK Incorporated offers two Creative Commons license options for open access publication:

- **Creative Commons Attribution 4.0 International (CC BY 4.0).** This license allows users to copy and distribute, to remix, transform, and build upon the article, for any purpose, even commercially, provided the author is attributed and is not represented as endorsing the use made of the work. - **Creative Commons Attribution-NonCommercial 4.0 International (CC BY-NC 4.0).** This license allows users to copy and distribute, to remix, transform, and build upon the article non-commercially, provided the author is attributed and the new work be non-commercial. Full details of this license are available at <http://creativecommons.org/licenses/by-nc/4.0/legalcode>

ARTICLE PROCESSING CHARGE AND WAIVERS

Upon acceptance of the article by a full open access journal, an article processing charge is due. This charge covers publishing activities including but not limited to peer review management; copyediting and typesetting; tagging and indexing of articles; hosting articles on dedicated servers; notification of errata, corrections, and retractions; and permanently preserving the published article.

No article will be published by a SLACK Incorporated full open access journal until the article processing charge is paid and the completed signed License Agreement for Open Access is received.

Requests to waive the article processing charge from authors originating in countries listed on the HINARI website <http://www.who.int/hinari/eligibility/en/> will be handled on case-by-case basis. Authors should email their request to the specific journal that accepted the article.

OPEN ACCESS CONTENT PUBLISHED IN SUBSCRIPTION JOURNALS (“DOUBLE DIPPING”)

SLACK Incorporated has a strict policy not to charge subscribers for open access content published in subscription journals (ie, “double dipping”). Individual subscription journal list prices are evaluated annually to account for every open access article published by that journal and adjust subscription journal prices accordingly.
